Operations. The group trained and flew patrols off the west coast, first in B-17s and later in B-24s, then moved to Hawaii in Oct-Nov 1942 where it trained and flew patrol and search missions. It attacked Wake Island, Dec 1942-Jan 1943, staging through Midway, and moved on to Guadalcanal in Feb 1943. The 307th flew combat missions primarily in the South and Southwest Pacific, attacking Japanese airfields, installations, and shipping in the Solomons and Bismarcks. It helped neutralize enemy bases in Yap and in the Truk and Palau Islands. For an unescorted, daylight mission to attack heavily defended airfields in the Truk Islands on 29 Mar 1944; it received a Distinguished Unit Citation (DUC). The group also supported operations in the Philippines by bombing airfields on Leyte, Luzon, Negros, Ceram, and Halmahera. It received a second DUC for an unescorted mission against vital oil refineries at Balikpapan, Borneo, on 3 Oct 1944. On 26 Oct 1944, the group bombed and damaged two Japanese battleships, one Yamato class and one Konga class, during the Battle of Leyte Gulf. In Aug 1946 it was equipped with B-29s and trained and developed antisubmarine tactics for SAC units. Following the outbreak of conflict in Korea, the group moved to Okinawa and attacked strategic objectives in North Korea, Aug-Sep 1950. After that it flew combat missions against interdictory targets, including communications and supply centers, and supported UN ground forces by attacking gun emplacements and troop concentrations through Feb 1951. Since operational control of the combat squadrons passed to the wing and the group existed mostly as a paper organization, wing commanders were also named group commanders as additional duty. In Jul 1977, the group was equipped with KC-135

aircraft and redesignated as a refueling group. It conducted air refueling on a global scale, Jul 1977-Oct 1983.
